I accept for use <b>AS IS</b> the equipment listed on this form, and accept full financial responsibility for the care of the equipment while it is in my possession. I will be responsible for replacement at full value of any equipment rented under this form, but not returned to the shop. I agree to return all rented equipment by the agreed date.					
I understand that the boot / binding system cannot guarantee the user's safety. In downhill skiing, the boot / binding system will not release at all times or under all circumstances where release may prevent injury or death, nor is it possible to predict every situation in which it will release. In snowboarding and SnowBlades use, the binding system will not ordinarily release during use; these bindings are not designed to release as a result of the forces generated during ordinary operation.					
I understand that the sport of skiing, snowboarding and SnowBlade, use and other recreational activities involve inherent and other risks of <b>INJURY</b> and <b>DEATH</b> . I voluntarily agree to expressly assume all risks of injury or death that may result from skiing / snowboarding or SnowBlade use, or which relate in any way to the use of this equipment.					
<b>I AGREE TO RELEASE</b> from any and all liability for injury, death, property loss and damage which results from equipment user's participation in the sport of skiing / snowboarding / SnowBlade use, or is in any way related to the use of this equipment, including all liability which results from <b>NEGLIGENCE OF PROVIDERS</b> , or any other person or cause.					
To the fullest extent allowed by law I agree to <b>RELEASE</b> from liability <b>N.Y.S.D.E.C.</b> , Belleayre Mountain, their employees, owners, affiliates, agents, officers, directors, and the manufacturers and distributors of this equipment (collectively " <b>PROVIDERS</b> "), or services under this Agreement, for any damages or death related the use of this equipment or services, whether such claim is based on negligence, breach of warranty, product defect or any other theory. I accept this equipment "As Is" with no warranties, express or implied. These waivers, releases and obligations extend to my heirs and assigns, and are applicable to the maximum extent permitted by law.
